**INTERIM CONSENT ORDER**

On or about January 24, 2022, the Maryland State Board of Massage Therapy Examiners (the “Board”) issued an “Order for Summary Suspension” against the license of Hasani Lori Adams (the “Respondent”), license number M05761. The Summary Suspension Order suspended the license of the Respondent to practice as a licensed massage therapist in the State of Maryland and was based on allegations that the Respondent inappropriately touched clients under his care. Due to this alleged conduct, the Respondent has been criminally charged in the District Court for Anne Arundel County, Case Nos. D07CR21008540 and D07CR21008640.

As the result of the Board’s Summary Suspension Order, the Respondent was provided with a show cause hearing before the Board on February 23, 2022. On consideration of the Respondent’s argument at the show cause hearing, the Board shall lift, pending the full evidentiary hearing in this matter, the suspension of the Respondent’s license.

Accordingly, it is hereby:

**ORDERED** that the summary suspension against the Respondent’s license to practice as a licensed massage therapist in the State of Maryland, license number M05761, is hereby **LIFTED** pending the full evidentiary hearing in this matter, subject to the following conditions:

1. The Respondent agrees not to engage in the practice of “massage therapy” as defined by Maryland Code Ann., Health Occ. §6-101(f)-(g) without the presence of a Board-

approved chaperone or chaperones, who must be present during any Respondent interaction with patients in the State of Maryland;


2. All chaperones must be pre-approved by the Board in writing;
3. The Respondent shall be subject to random inspections and audits by the Board in order to determine compliance with this Order;
4. Throughout the pendency of this Interim Order, the Board-approved chaperone(s) shall provide written quarterly reports to the Board regarding the Respondent's compliance with this Order;
5. Within **FIVE (5) DAYS** of the disposition of the criminal cases in the District Court for Anne Arundel County, Case Nos. D07CR21008540 and D07CR21008640, the Respondent shall arrange to provide the Board with certified docket entries detailing the dispositions; and
6. The Respondent is responsible for all costs associated with the compliance of this Order; and it is further

**ORDERED** that if, in its sole determination, the Board determines that the Respondent has failed to comply with the terms and conditions of this Interim Consent Order, the Board may re-impose the summary suspension of his license to practice massage therapy; and it is further

**ORDERED** that, on disposition of the pending criminal charges in the District Court for Anne Arundel County, Case Nos. D07CR21008540 and D07CR21008640, an evidentiary hearing on the merits of the Order for Summary Suspension of License to Practice Massage Therapy shall be scheduled as soon as practicable; and it is further

**ORDERED** that this Interim Consent Order of the Maryland State Board of Massage Therapy Examiners is a **PUBLIC DOCUMENT** pursuant to Md. Code Ann., General Provisions §§ 4-101 *et seq.*


**CONSENT**
