PRE-CHARGE CONSENT ORDER

Background

On August 15, 2007, the Maryland Board of Chiropractic Examiners (the "Board") received an application from Carla Schectman (the "Respondent"). On Ms. Schectman's application, she failed to disclose that she had twice been sentenced to probation before judgment for possession of marijuana. Subsequently, the Board's conducting its own investigation of this matter. The Board had reason to believe that the Respondent should be issued a license and serve one year of probation.

In lieu of issuing Charges against the Respondent for violation of the Maryland Chiropractic Act, Md. Code Ann., Health Occ. §§ 3-101 *et seq.*, the Board has voted to enter into this Pre-Charge Consent Order with the Respondent as a resolution of this matter.

FINDINGS OF FACT

1. Ms. Schectman applied for a license to become a Certified Massage Therapist on August 15, 2007.
2. On September 15, 2004, Ms. Schectman was stopped by police officer in Baltimore, Maryland. The officer conducted a search of Ms. ~~Balt~~'s car and found marijuana and drug paraphernalia. *Schectman's car 6/30/08*
3. On October 27, 2004, Ms. Schectman received probation before judgment and was sentenced to two years probation for possession of marijuana with intent to distribute.

4. On November 12, 2004, Ms. Schectman was stopped by police officer in Baltimore County. The officer conducted a search of Ms. ~~Dee~~'s car and found marijuana and drug paraphernalia.

5. On February 18, 2005, Ms. Schectman received probation before judgment and was sentenced to three years probation for possession of marijuana with intent to distribute.
6. As of the date of this order, Ms. Schectman had successfully completed all the terms of her probation.

CONCLUSIONS OF LAW

Based on the foregoing Findings of Fact, the Board concludes that the Respondent has violated Md. Code Ann., Health Occ. §§3-5A--09(11) and 3-5A--11(a).

ORDER

Based on an affirmative vote of a quorum of the Board, it is this 30th day of June, 2008, hereby:

ORDERED that the Respondent's license to practice massage therapy be issued and that the licensee serve twelve months of probation; and be it further

ORDERED that during this probationary period, the Respondent shall be tested randomly for illegal drugs at a time and manor chosen by the Board;

ORDERED that the Respondent shat practice in accordance with the laws and regulations governing the practice of Massage Therapy in Maryland; and be it further

ORDERED that the Respondent shall at all times cooperate with the Board and all treatment providers in the monitoring, supervision, and investigation of the Respondent's compliance with the terms and conditions of this Consent Order; and be it further,

ORDERED that the Respondent shall be responsible for all costs associated with this Consent Order; and be it further,

ORDERED that this is a formal order of the Maryland Board of Chiropractic Examiners and as such is a public document pursuant to the Maryland Annotated Code, State Government Article, Section 10-617(h).
